# **Privacy Policy**

#### We respect your privacy

- 1. Accent HR Pty Ltd respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. This policy sets out how we collect and treat your personal information.
- 2. We adhere to the Australian Privacy Principles contained in the Privacy Act 1988 (Cth) and to the extent applicable, the EU General Data Protection Regulation (GDPR).
- 3. "Personal information" is information we hold which is identifiable as being about you. This includes information such as your name, email address, identification number, or any other type of information that can reasonably identify an individual, either directly or indirectly.

### What personal information is collected

- 1. Accent HR Pty Ltd will, from time to time, receive and store personal information you submit to our website, provided to us directly or given to us in other forms including through a third party.
- 2. You may provide basic information such as your name, phone number, address and email address to enable us to send you information, provide updates and process your product or service order.
- 3. We may collect additional information at other times, including but not limited to, when you provide feedback, when you provide information about your personal or business affairs, change your content or email preference, respond to surveys and/or promotions, provide financial or credit card information, or communicate with our customer support.
- 4. Additionally, we may also collect any other information you provide while working with us such as date of birth, ACN, ABN, ARBN, resumes and employment details, social media account names, bank account details and business records.

# How we collect your personal information

- Accent HR Pty Ltd collects personal information from you in a variety of ways, including but not limited to, when you interact with us electronically or in person, when you access our website and when we engage in business activities with you. We may receive personal information from third parties. If we do, we will protect it as set out in this Privacy Policy.
- 2. By providing us with personal information, you consent to the supply of that information subject to the terms of this Privacy Policy.

## How we use your personal information

Accent HR Pty Ltd may use personal information collected from you to provide you with information about our products or services. We may also make you aware of new and additional products, services and opportunities available to you.

Accent HR Pty Ltd will use personal information only for the purposes that you consent to. This may include to:

- 1. provide you with products and services during the usual course of our business activities;
- 2. administer our business activities;
- 3. manage, research and develop our products and services;
- 4. provide you with information about our products and services;
- 5. communicate with you by a variety of measures including, but not limited to, by telephone, email, sms or mail; and

We may disclose your personal information to comply with a legal requirement, such as a law, regulation, court order, subpoena, warrant, legal proceedings or in response to a law enforcement agency request.

If there is a change of control in our business or a sale or transfer of business assets, we reserve the right to transfer to the extent permissible at law our user databases, together with any personal information and non-personal information contained in those databases.

# **Disclosure of your personal information**

- 1. Accent HR Pty Ltd may disclose your personal information to any of our employees, officers, insurers, professional advisers, agents, suppliers or subcontractors insofar as reasonably necessary for the purposes set out in this privacy policy.
- 2. If we do disclose your personal information to a third party, we will protect it in accordance with this privacy policy.

# General Data Protection Regulation (GDPR) for the European Union (EU)

- 1. Accent HR Pty Ltd will comply with the principles of data protection set out in the GDPR for the purpose of fairness, transparency and lawful data collection and use.
- 2. We process your personal information as a Processor and/or to the extent that we are a Controller as defined in the GDPR.
- 3. We must establish a lawful basis for processing your personal information. The legal basis for which we collect your personal information depends on the data that we collect and how we use it.
- 4. We will only collect your personal information with your express consent for a specific purpose and any data collected will be to the extent necessary and not excessive for its purpose. We will keep your data safe and secure.
- 5. We will also process your personal information if it is necessary for our legitimate interests, or to fulfil a contractual or legal obligation.

- 6. We process your personal information if it is necessary to protect your life or in a medical situation, it is necessary to carry out a public function, a task of public interest or if the function has a clear basis in law.
- 7. We do not collect or process any personal information from you that is considered "Sensitive Personal Information" under the GDPR, such as personal information relating to your sexual orientation or ethnic origin unless we have obtained your explicit consent, or if it is being collected subject to and in accordance with the GDPR.
- 8. You must not provide us with your personal information if you are under the age of 16 without the consent of your parent or someone who has parental authority for you. We do not knowingly collect or process the personal information of children.

#### Your rights under the GDPR

If you are an individual residing in the EU, you have certain rights as to how your personal information is obtained and used. Accent HR Pty Ltd complies with your rights under the GDPR as to how your personal information is used and controlled if you are an individual residing in the EU.

Except as otherwise provided in the GDPR, you have the following rights:

- 1. to be informed how your personal information is being used;
- 2. access your personal information (we will provide you with a free copy of it);
- 3. to correct your personal information if it is inaccurate or incomplete;
- 4. to delete your personal information (also known as "the right to be forgotten");
- 5. to restrict processing of your personal information;
- 6. to retain and reuse your personal information for your own purposes;
- 7. to object to your personal information being used; and
- 8. to object against automated decision making and profiling.

- 3. The hosting facilities for our website are situated in Australia. Transfers to other Countries will be protected by appropriate safeguards, these include one or more of the following: the use of standard data protection clauses adopted or approved by the European Commission which you can obtain from the European Commission Website; the use of binding corporate rules.

- 4. Our Suppliers and Contractors are situated in Australia. Transfers to other Countries will be protected by appropriate safeguards, these include one or more of the following: the use of standard data protection clauses adopted or approved by the European Commission which you can obtain from the European Commission Website; the use of binding corporate rules.
- 5. You acknowledge that personal data that you submit for publication through our website or services may be available, via the internet, around the world. We cannot prevent the use (or misuse) of such personal data by others.

## Security of your personal information

Although we take measures to safeguard against unauthorised disclosures of information, we cannot assure you that personal information that we collect will not be disclosed in a manner that is inconsistent with this Privacy Policy.
- 4. We will take reasonable steps to destroy or permanently de-identify personal information if it is no longer required or if you ask us. We are however required by law to retain personal information in order to fulfil legal responsibilities or resolve disputes which may arise.

#### Access to your personal information
